LD 1891 / SP0804

An Act to Make Interstate Bank Ownership Possible. Presented by Sen. Clark of Cumberland; Co-sponsored by Sen. Collins of Knox, Rep. Brannigan of Portland, Rep. Jackson of Yarmouth. Business Legislation Hearing 2-23-82. Majority OTP-ND (SP0950 / LD 2100) Accepted by Senate (Minority O.N.T.P.). In House - Indefinitely Postponed. Died Between Houses.
