Resolve, Authorizing the Maine Forest Service to Convey by Bid Sale of the State's Interest in Certain Real Estate in the Maine Forestry District and to Use the Proceeds for Energy-saving Improvements to Other Existing Fire Control Buildings. Presented by Rep. Hall of Sangerville; Co-sponsored by Rep. Dexter of Kingfield, Rep. Post of Owls Head, Sen. Teague of Somerset. Taxation Hearing 2-18-82. OTP-AM Accepted. Amended by: CA H-609. Finally Passed, Approved 5-14-82, RESOLVE LAWS, Chapt. 68.
