LD 1949 / HP1974

An Act to Eliminate the 2¢ Excise Tax Imposed on Jet Fuel Used by International Flights. Presented by Rep. Kelleher of Bangor; Co-sponsored by Sen. Emerson of Penobscot, Rep. Diamond of Bangor, Rep. Tarbell of Bangor. Taxation Hearing 2-25-82. OTP-AM Accepted. Amended by: CA H-719. In House - Enacted; In Senate - Referred to Appropriations & Financial Affairs Committee. Died Between Houses. (Cf. LD 2144, Pt. R)
