An Act Relating to the Closing of State Liquor Stores in Communities with One Store. Presented by Rep. Carter of Winslow; Co-sponsored by Rep. Fitzgerald of Waterville, Sen. Teague of Somerset. Legal Affairs Hearing 3-2-82. Majority OTP-AM Accepted (Minority OTP-AM). Amended by: CA H-641. In House - Adhered to Engrossing with CA and HA; In Senate - Adhered to Engrossing with CA. Died Between Houses.
