An Act Creating the Housing Opportunities for Maine (HOME) Program and Governing Program Funds Appropriated by this Act to the Maine State Housing Authority. Presented by Rep. Martin of Eagle Lake; Co-sponsored by Rep. Murphy of Kennebunk, Sen. Conley of Cumberland, Sen. Ault of Kennebec. State Government Hearing 3-1-82. O.T.P. Accepted. Amended by: HD H-683. In House - Enacted; In Senate - Referred to Appropriations & Financial Affairs Committee. Died Between Houses. (Cf. LD 2144, Pt. S)
