LD 2017 / HP2074

An Act to Index Annually the Standard Deduction Provision of the Maine Personal Income Tax and to Provide for a Statutory Referendum. Presented by Rep. Post of Owls Head; Co-sponsored by Sen. Pierce of Kennebec, Sen. Teague of Somerset, Rep. Benoit of So. Portland. Taxation Hearing 3-5-82. Majority OTP-AM; Minority O.T.P. Accepted by House. In House - Adhere to Engrossing; In Senate - Insisted on Indefinite Postponement. Died Between Houses.
