LD 2061 / SP0920

Resolution, Proposing an Amendment to the Constitution of Maine to Authorize the Credit of the State to be Loaned to Secure Funds for Loans to Parents of Maine Students Attending Institutions of Higher Education. Presented by Sen. Trotzky of Penobscot; Co-sponsored by Sen. Clark of Cumberland. Education Hearing 3-22-82. O.T.P. Accepted. Finally Passed, CON RES LAWS, Chapt. 5. Approved in Referendum, 11-2-82 (In favor: 257,040; Opposed: 162,696).
