An Act to Remove the Retroactive Provisions of the Income Tax Indexing Law. Presented by Sen. McBreairty of Aroostook; Co-sponsored by Rep. Kelleher of Bangor, Rep. Matthews of Caribou, Rep. Anderson of Stockholm. Taxation Hearing 1-4-83. Majority O.T.P. Accepted (Minority O.N.T.P.). Amended by: HC H-5. Emerg. Enacted, Approved 1-14-83, PUBLIC LAWS, Chapter 3.
