LD 278 / HP0230 (ND 1708 / HP1288)

An Act Concerning the Rate of Return on Investment Factor under the Railroad Excise Tax. Presented by Rep. Kelleher of Bangor; Co-sponsored by Sen. Wood of York, Rep. Manning of Portland, Rep. Brown of Bethel. Taxation Hearing 2-10-83. OTP-ND Accepted. NEW DRAFT: HP1288 / LD 1708. Enacted. This Bill was Neither Signed nor Vetoed by the Governor. Pursuant to Joint Order, HP 1417, This Bill was Recalled from the Governor's Desk to the House. Amended by HA H-449. Emerg. Enacted, Approved 2-1-84, PUBLIC LAWS, Chapter 593.
