LD 481 / HP0398

An Act to Amend Maine's Wrongful Death Law. Presented by Rep. Soule of Westport; Co-sponsored by Sen. Carpenter of Aroostook. Judiciary Hearing 2-23-83. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA H-141. In House - Adhered to Indefinite Postponement; In Senate Enacted. Died Between Houses.
