An Act to Protect Employees from Reprisal who Report or Refuse to Commit Illegal Acts. Presented by Rep. Andrews of Portland; Co-sponsored by Rep. Gauvreau of Lewiston, Rep. Beaulieu of Portland, Sen. Hayes of Penobscot. Judiciary Hearing 4-11-83. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA H-274, HA/CA H-313. Enacted, Approved 6-16-83, PUBLIC LAWS, Chapter 452.
