NEW DRAFT: HP1042 / LD 1349, NEW TITLE: Resolution, Proposing an Amendment to the Constitution of Maine to Provide that the State may Enact Property Tax Exemptions Relating to Watercraft not Subject to Fifty Percent Reimbursement. Amended by: HA H-241. Finally Passed, 6-23-83, CON RES LAWS, Chapter 3. Failed in Referendum, 11-8-83 (In favor: 133,605; Opposed: 151,499).
