An Act Relating to Authority of the Land Use Regulation Commission over Organized Municipalities. Presented by Sen. McBreairty of Aroostook; Co-sponsored by Rep. Vose of Eastport. Energy & Natural Resources Hearing 3-23-83. (Majority O.N.T.P.) Minority O.T.P. Accepted. Amended by: SA S-110. In House Indefinitely Postponed; In Senate - Enactment Failed. Died Between Houses.
