LD 992 / HP0761

Resolve, to Reimburse David James McDaniel for Damages Suffered as a Result of Wrongful Imprisonment. Presented by Speaker Martin of Eagle Lake. Judiciary Hearing 4-25-83. This Bill was Retained by the Committee until the Second Regular Session. (Majority O.N.T.P.) Minority O.T.P. Accepted. Amended by: HA H-591, HA/HA H-664. Enacted. This Bill was Vetoed by the Governor and Returned to the Legislature in Special Session. The Veto was not overruled.
