LD 1067 / HP0829

An Act to Regulate Smoking on Public Conveyances in the State of Maine. Presented by Rep. Reeves of Pittston; Co-sponsored by Rep. Manning of Portland, Sen. Bustin of Kennebec. Health & Institutional Services Hearing 4-8-83. Majority OTP-ND (HP1211 / LD 1604) Accepted by House; Minority O.N.T.P. Accepted by Senate. The Committee of Conference reported that they were Unable to Agree.
