An Act to Incorporate Last Best Offer Provisions into the Municipal Public Employees and the University of Maine Labor Relations Laws. Presented by Rep. Diamond of Bangor; Co-sponsored by Rep. Cox of Brewer, Rep. Weymouth of West Gardiner, Sen. Hayes of Penobscot. Labor Hearing 4-7-83. (Majority O.N.T.P.) Minority OTP-ND Accepted. NEW DRAFT: HP1267 / LD 1678. In House - Adhered to Failed to Enact; In Senate - Enacted. Died Between Houses.
