LD 1302 / HP0992 (ND 2369 / HP1794)

An Act to Prohibit the State from Charging Fees to the General Public for Access to Public Lands. Presented by Rep. Jacques of Waterville; Co-sponsored by Rep. McGowan of Pittsfield, Rep. Dexter of Kingfield, Rep. Michael of Auburn. Energy & Natural Resources Hearing 4-20-83. This Bill was Retained by the Committee until the Second Regular Session. OTP-ND Accepted. NEW DRAFT: HP1794 / LD 2369, NEW TITLE: An Act to Require the Bureau of Public Lands to Report Annually to the Legislature on the Existing of Barriers to and Fees for Public Access to Public Reserved Lands. Enacted, Approved 4-9-84, PUBLIC LAWS, Chapter 715.
