History and Final Disposition

LD 1364 / HP1039

An Act to Amend the Law Relating to Tax Increment Financing. Presented by Rep. Hayden of Durham; Co-sponsored by Rep. Murray of Bangor, Rep. Masterman of Milo, Sen. Wood of York. Taxation Hearing 4-28-83. Majority O.T.P. Accepted (Minority O.N.T.P.). Enacted. Pursuant to Joint Order, HP 1341, this Bill was Recalled from the Governor's Desk and Recommitted to the Taxation Committee. This Bill was Retained by the Committee until the Second Regular Session. OTP-AM Accepted. Amended by: CA H-643. Enacted, Unsigned, PUBLIC LAWS, Chapter 858. (Note: Presented to Governor 4-25-84; received by Secretary of State 9-10-84.)

Joint Order, That "An Act to Amend the Law Relating to Tax Increment Financing" (HP 1039) (LD 1364) be recalled from the Governor's desk. Presented by Rep. Higgins of Portland. Passed in Concurrence, 6-21-83.
