An Act to Authorize Municipalities to Guarantee Delivery of their Solid Wastes to Specific Waste Facilities. Presented by Rep. Mitchell of Vassalboro; Co-sponsored by Rep. Michael of Auburn, Rep. Bost of Orono, Sen. Twitchell of Oxford. Energy & Natural Resources Hearing 4-20-83. Majority O.T.P. Accepted (Minority O.N.T.P.). Amended by: SA S-120. Enacted, Approved 6-3-83, PUBLIC LAWS, Chapter 380.
