LD 1479 / SP0486 (ND 1719 / SP0597)

An Act to Prevent Unjust Enrichment by Retention of Surplus Upon Foreclosure of Municipalities and Sewer Districts. Presented by Sen. Najarian of Cumberland; Co-sponsored by Sen. Trafton of Androscoggin, President Conley of Cumberland, Rep. Manning of Portland. Judiciary Hearing 5-4-83. (Majority O.N.T.P.) Minority OTP-ND Accepted. NEW DRAFT: SP0597 / LD 1719. Amended by: SA S-183. Recommitted to Judiciary. This Bill was Retained by the Committee until the Second Regular Session. Majority O.N.T.P. Accepted by House; Minority OTP-ND (SP0905 / LD 2433) Accepted by Senate. In House - Adhered to Majority Report; In Senate - Adhered to Minority Report. Died Between Houses.
