LD 1499 / HP1137

An Act to Provide for Consumer Representation before the Maine Milk Commission. Presented by Rep. Kelleher of Bangor; Co-sponsored by Sen. Baldacci of Penobscot, Rep. Kane of South Portland, Rep. Michael of Auburn. Agriculture Hearing 5-11-83. Majority O.N.T.P. Accepted by House; Minority O.T.P. Accepted by Senate. In House Adhere to Majority Report (O.N.T.P.); In Senate - Engrossed as Amended. Died Between Houses.
