LD 1564 / SP0533 (ND 1748 / SP0613)

An Act to Streamline Information Processing by Income Supplementation and Social Service Programs. Presented by Sen. Bustin of Kennebec, Co-sponsored by Sen. Gill of Cumberland, Sen. Hayes of Penobscot, Rep. Davis of Monmouth. Health & Institutional Services Hearing 5-19-83. Leave to Withdraw Accepted. Pursuant to Joint Order, SP 610, this Bill was Recalled from the Dead Files to the Senate and Recommitted to the Health & Institutional Services Committee. OTP-ND Accepted. NEW DRAFT: SP0613 / LD 1748, NEW TITLE: Resolve, Authorizing the Streamlining of Information Processing by Income Supplementation and Social Service Programs. Emerg. Finally Passed, Approved 6-24-83, RESOLVE LAWS, Chapter 41.
