LD 1607 / HP1208 (ND 1797 / HP1364)

An Act to Provide Additional Revenue to the Department of Inland Fisheries and Wildlife Through an Increase in License Fees. Presented by Rep. MacEachern of Lincoln; Co-sponsored by Rep. Roderick of Oxford, Sen. Dow of Kennebec. Fisheries & Wildlife Hearing 5-19-83. OTP-ND (HP1312 / LD 1741). Recommitted to Fisheries & Wildlife. OTP-ND (HP1364 / LD 1797) (OTP-ND (HP1365 / LD 1798)) (O.N.T.P.). NEW TITLE: An Act to Provide Additional Revenue to the Department of Inland Fisheries and Wildlife by an Increase in License Fees and to Allocate Those Increased Revenues to the Department of Inland Fisheries and Wildlife for the Fiscal Years Ending June 30, 1984, and June 30, 1985. Amended by: HA H-439, SA/HA S-274. Enacted, Approved 9-15-83, PUBLIC LAWS, Chapter 588.
