LD 1617 / HP1218 (ND 2426 / HP1832)

An Act to Modify Early Retirement Plans for State Employees Hired After September 30, 1983. Presented by Rep. McCollister of Canton. Aging, Retirement & Veterans Hearing 5-26-83. This Bill was Retained by the Committee until the Second Regular Session. OTP-ND Accepted (OTP-ND: HP1833 / LD 2427) (OTP-ND: HP1834 / LD 2428). NEW DRAFT: HP1832 / LD 2426. Enacted, Approved 4-13-84, PUBLIC LAWS, Chapter 751.
