LD 1690 / SP0582

An Act to Authorize a Bond Issue in the Amount of \$3,000,000 for the Elimination of Asbestos Hazards in Public School Buildings. Presented by Sen. Baldacci of Penobscot; Co-sponsored by Sen. Perkins of Hancock, Rep. Beaulieu of Portland, Rep. Matthews of Caribou. Appropriations & Financial Affairs. This Bill was Retained by the Committee until the Second Regular Session. Appropriations & Financial Affairs Hearing 3-22-84. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA S-413. Enactment Failed.
