LD 1806 / HP1374

An Act Providing Conformity with the United States Internal Revenue Code. Presented by Rep. Higgins of Portland; Co-sponsored by Sen. Wood of York, Rep. Cashman of Old Town. Taxation Hearing 11-16-83. Majority OTP-AM Accepted (Minority OTP-AM). Amended by CA H-440, HA H-444. Enacted, Approved 11-21-83, PUBLIC LAWS, Chapter 590.
