LD 1872 / HP1427

An Act to Permit Public Service in Lieu of Fines for Indigent Offenders Under the Drunk Driving Law. Presented by Rep. Gauvreau of Lewiston; Co-sponsored by Sen. Trafton of Androscoggin, Rep. Benoit of South Portland, Rep. Mayo of Thomaston. Judiciary. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA H-530. In House - Indefinitely Postponed. Committee of Conference reported that they were Unable to Agree.
