An Act Relating to Alcohol-related Birth Defects. Presented by Sen. Bustin of Kennebec; Co-sponsored by Sen. Gill of Cumberland, Rep. Diamond of Bangor, Rep. Masterman of Milo. Alcoholism Services Hearing 3-22-84. Majority OTP-ND Accepted (Minority O.N.T.P.). NEW DRAFT: SP0880 / LD 2384. Enacted. Vetoed by Governor. Veto Sustained in Senate.
