An Act to Amend the Statute Relating to the Sale and Free Distribution of Cigarettes to Children. Presented by Rep. Kane of South Portland; Co-sponsored by Rep. Benoit of South Portland, Rep. Manning of Portland. Health & Institutional Services Hearing 3-27-84. Majority OTP-AM Accepted by House; Minority O.N.T.P. Accepted by Senate. In House - Adhered to Engrossed with CA; In Senate - Adhered to Minority Report (O.N.T.P.). Died Between Houses.
