LD 2256 / HP1703

Resolution, Proposing an Amendment to the Constitution of Maine to Enable the Legislature to Establish the Extent of Insurance of Loans to Veterans. Presented by Rep. Gwadosky of Fairfield; Co-sponsored by Rep. Carroll of Limerick, Rep. Cooper of Windham, Sen. Carpenter of Aroostook. State Government Hearing 3-22-84. O.T.P. Accepted. Amended by: HA H-622. Finally Passed, 4-24-84, CON RES LAWS, Chapter 6. Approved in Referendum, 11-6-84 (In favor: 296,299; Opposed: 206,760).
