LD 2340 / HP1772

An Act to Authorize a General Fund Bond Issue in the Amount of \$15,735,000 to Plan, Construct and Equip Pollution Abatement Facilities and to Abate, Clean Up and Mitigate Threats to Public Health and the Environment from Uncontrolled Hazardous Substance Sites. Presented by Rep. Carroll of Gray; Co-sponsored by Sen. Twitchell of Oxford, Sen. Dow of Kennebec. Appropriations & Financial Affairs Hearing 3-26-84. Majority OTP-AM Accepted (Minority OTP-AM). Amended by: CA H-700, HB/CA H-739. Emerg. Enacted, Approved 4-26-84, P & S LAWS, Chapter 99. Approved in Referendum, 6-12-84 (In favor: 66,430; Opposed: 24,271).
