LD 2351 / HP1785

An Act to Place Limitations on the Contributions which Candidates may Receive from Political Action Committees. (Reported Pursuant to a Study from the Election Laws Committee.) Election Laws Hearing 4-4-84. O.N.T.P. Accepted by Senate (OTP-ND: HP1850 / LD 2448) (O.T.P.). In House - Indefinitely Postponed. Died Between Houses.
