An Act to Fairly Apportion the Cost of Canceled Electric Generating Facilities. Presented by Rep. Vose of Eastport; Co-sponsored by Sen. Danton of York, Sen. Collins of Knox, Rep. McGowan of Pittsfield. Public Utilities Hearing 4-5-84. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA H-675, HB H-719. Enacted, Approved 4-24-84, PUBLIC LAWS, Chapter 811.
