An Act to Revise Certain Portions of the Tax Laws Relative to Income Tax Conformity, Sales Taxes, Real Estate Transfer Taxes and Cigarette Taxes. Presented by Rep. Higgins of Portland; Co-sponsored by Rep. Kane of So. Portland, Rep. Cashman of Old Town, Sen. Wood of York. Taxation. (OTP-ND: HP1898 / LD 2494) (O.N.T.P.) OTP-ND Accepted. NEW DRAFT: HP1899 / LD 2495). Amended by: HB H-767. Died on Adjournment, but Substance of bill enacted in LD 2492 as amended by HA H-769, Pts. M and N.
