LD 391 / HP0302

An Act to Authorize the Use of Energy Service Companies and 3rd-Party Financing for Conservation Improvements at State Facilities. Presented by Rep. Gwadosky of Fairfield; Co-sponsored by Sen. Kany of Kennebec, Sen. Andrews of Cumberland, Rep. McGowan of Canaan. State Government Hearing 02-21-85. Majority O.T.P. Accepted (Minority O.N.T.P.). Enacted, Approved 04-30-85, PUBLIC LAWS, Chapter 128.
