An Act to License Dietitians. Presented by Sen. Gill of Cumberland; Co-sponsored by Sen. Bustin of Kennebec, Rep. Telow of Lewiston, Rep. Martin of Van Buren. Business and Commerce Hearing 02-21-85. Majority OTP-ND Accepted (Minority O.N.T.P.). NEW DRAFT: SP0520 / LD 1397. Enacted. Vetoed by Governor. Veto Sustained in Senate.
