An Act to Divest State Money from Businesses Investing in South Africa and Namibia. Presented by Rep. Baker of Portland; Co-sponsored by Rep. Martin of Eagle Lake, RICHARD OF MADISON, Sen. Matthews of Kennebec. State Government Hearing 03-19-85. This Bill was Retained by the Committee until the Second Regular Session. Leave to Withdraw Accepted 03-24-86.
