LD 584 / SP0221

An Act to Reimburse the Unorganized Territory Education and Services Fund for Overcharges from 1978 to 1983. Presented by Sen. McBreairty of Aroostook; Co-sponsored by Rep. Conners of Franklin, Sen. Twitchell of Oxford, Rep. Martin of Van Buren. Taxation Hearing 03-28-85. Leave to Withdraw Accepted. Recalled from the Legislative Files to the House pursuant to Joint Order HP 1156. Bill substituted for the report. Amended by: HA H-481. Enacted, Approved 06-27-85, PUBLIC LAWS, Chapter 458.

Joint Order, That the Bill "An Act to Reimburse the Unorganized Territory Education and Services Fund for Overcharges from 1978 to 1983," (SP 221) (LD 584) be recalled from the legislative files to the House. Presented by Rep. Cashman. Passed in Concurrence, 06-19-85.
