LD 885 / HP0615

An Act to Adjust the Excise Tax on Watercraft. Presented by Rep. Zirnkilton of Mount Desert; Co-sponsored by Sen. Twitchell of Oxford, Sen. Sewall of Lincoln, Sen. Danton of York. Taxation Hearing 04-10-85. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA H-454. House - Adhered to Indefinite Postponement; Senate Enacted. Died Between Houses.
