Resolution, Proposing an Amendment to the Constitution of Maine to Provide for Staggered 4-year Terms for Senators. Presented by Sen. Pray of Penobscot; Co-sponsored by Sen. Dow of Kennebec, Sen. Violette of Aroostook, Sen. Perkins of Hancock. State Government Hearing 04-18-85. Majority O.T.P. Accepted by Senate; Minority O.N.T.P. Accepted by House. Conference Report Accepted (Unable to Agree). Died Between Houses.
