An Act to Authorize an Award System to Aid in Coyote Control. Presented by Rep. Smith of Island Falls; Co-sponsored by Sen. Black of Cumberland, Rep. Erwin of Rumford, Rep. Bell of Paris. Fisheries and Wildlife Hearing 05-07-85. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CC/CA H-424. Enacted. Vetoed. Veto Sustained in House, 01-13-86.
