LD 1220 / HP0861

An Act Providing for Administrative Changes in Maine Tax Law. Presented by Rep. Higgins of Portland; Co-sponsored by Rep. Jackson of Harrison, Rep. Aliberti of Lewiston, Sen. Twitchell of Oxford. Taxation Hearing 04-30-85. OTP-AM Accepted. Amended by: CA H-470. Enacted. Pursuant to Joint Order HP1271, this Bill was Recalled from the Governor's Desk. Amended by: HA H-493. Enacted, Approved 02-19-86, PUBLIC LAWS, Chapter 535.

Joint Order, That Bill, "An Act to Provide a Sales Tax, Trade-in Credit for Loaders and Chain Saws used to Harvest Lumber," H.P. 72, L.D. 93; and that Bill "An Act Providing for Administrative Changes in the Maine Tax Law," H.P. 861, L.D. 1220, be recalled from the Governor's desk to the House. Presented by Rep. Cashman of Old Town. Passed in Concurrence, 01-08-86.
