An Act to Expand and Continue Alcoholism Treatment, Education, Prevention and Research Programs. Presented by Rep. Brodeur of Auburn; Co-sponsored by Rep. Rolde of York, Sen. Bustin of Kennebec, Sen. Stover of Sagadahoc. Taxation Hearing 05-07-85. Majority OTP-AM Accepted (Minority OTP-ND (HP1464 / LD 2066). Amended by: CA H-532, SH/CA S-502. Enacted, Approved 04-26-86, PUBLIC LAWS, Chapter 803.
