LD 1467 / SP0550

Resolve, Authorizing Colwell Construction Company, Incorporated, to Bring a Civil Action Against the State of Maine. Presented by Sen. Bustin of Kennebec; Co-sponsored by Rep. Hickey of Augusta. Legal Affairs Hearing 05-14-85. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA S-242. Finally Passed. Pursuant to Joint Order, SP 689, Recalled from the Governor's Desk. Indefinitely Postponed.

Joint Order, That "Resolve Authorizing Colwell Construction Company, Incorporated, to Bring a Civil Action Against the State of Maine," S.P. 550, L.D. 1467, be recalled from the Governor's desk to the Senate. Presented by Sen. Bustin of Kennebec. Passed in Concurrence, 01-08-86.
