Original Title: An Act to Authorize the Issuance of a Bond not Exceeding \$8,000,000 for the Financing of the Maine Inland Fisheries and Wildlife Acquisition Fund. Amended by: CB (Changed Title) S-550. Enacted, Approved 06-06-86, P & S LAWS, Chapter 138. Approved in Referendum, 11-04-86 (In favor: 248,891; Opposed: 151,822).
