An Act to Establish Policies Governing Medical Malpractice Claims. Presented by Sen. Twitchell of Oxford; Co-sponsored by Rep. Jackson of Harrison. Judiciary Hearing 03-13-86. Majority O.N.T.P. Report Accepted by Senate; Minority OTP-ND SP0940 / LD 2354 Accepted by House. Died Between Houses.
