LD 2005 / SP0798

An Act to Amend the Requirement that all Part-time Law Enforcement Officers be Trained by the Maine Criminal Justice Academy. Presented by Sen. Webster of Franklin; Co-sponsored by Rep. Rotondi of Athens, Rep. McGowan of Canaan, and Rep. Dexter of Kingfield. State Government Hearing 02-25-86. Majority O.N.T.P. Accepted by Senate; Minority OTP-AM Accepted by House. Died Between Houses.
