An Act to Establish the Maine Small Business and Job Development Program. Presented by Sen. Andrews of Cumberland; Co-sponsored by Sen. Pray of Penobscot, Rep. Hayden of Brunswick, and Rep. Holloway of Edgecomb. Appropriations & Financial Affairs Hearing 03-14-86. Majority OTP-ND-NT Accepted 04-12-86 (Minority O.N.T.P.). NEW DRAFT: SP0952 / LD 2387, NEW TITLE; An Act to Establish the Maine Business Opportunity and Job Development Program. Senate - Enacted; House - Engrossed as Amended. Recommitted to Appropriations and Financial Affairs Pursuant to Joint Order, Carried Over to the Next Special Session. Majority OTP-ND-NT Accepted 05-28-86 (Minority O.N.T.P.).
