Resolve, Creating a Maine Commission to Commemorate the Bicentennial of the United States Constitution. Presented by Sen. Pray of Penobscot; Co-sponsored by Rep. Martin of Eagle Lake, Sen. Carpenter of Aroostook, and Rep. Kane of South Portland. State Government Hearing 03-25-86. Majority OTP-AM Accepted 04-01-86 (Minority OTP-AM). Amended by: CA S-443, SA/CA S-504. Emergency Finally Passed, Approved 04-24-86, RESOLVE LAWS, Chapter 85.
