Original Title: An Act to Prohibit a Doe Permit System until June 1, 1987. New Title: An Act to Prohibit a Doe Permit System until February 1, 1987. Presented by Rep. Smith of Island Falls; Co-sponsored by Rep. Conners of Franklin, Rep. Webster of Cape Elizabeth, and Sen. Dow of Kennebec. Fisheries & Wildlife Hearing 03-25-86. Majority OTP-AM Accepted 04-08-86 (Minority O.N.T.P.). Amended by: CA (Changed Title) H-630. Enacted. The Governor Neither Signed nor Vetoed this Bill (Pocket Veto).
